
Affordable Care Act

REPEAL

Through a “Budget Reconciliation”

= Things that cost money

Simple majority to pass (51 votes)



→ This would result in a significant loss of federal dollars to CA (\$20 billion)

→ Partial repeal would triple uninsured rate for CA kids (from 2.8% to 10.1 %; Urban Institute)

Affordable Care Act

REPLACE

Requires bipartisan support (needs 60 votes in Senate to bypass a filibuster)



Other Potential Changes to Healthcare

Medicaid Block Grants/Per Capita Caps

- Risk to Medi-Cal: CA may not receive sufficient resources to maintain program as it is today
- FamilyPACT, School Medicaid billing, CHDP screenings?

Reproductive Health: FamilyPACT, Title X

Reauthorization of CHIP & FQHC/330 grants (Sept 2017)

Education

Every Student Succeeds Act (ESSA)

- Bipartisan replacement for No Child Left Behind
- Already includes a lot of state flexibility: states must create their state plans to the federal government
- California plans to submit plan: September 2017



Deferred Action for Childhood Arrivals

DACA has allowed over 740,000 young people a reprieve from deportation and a renewable work permit.

Thanks to DACA, thousands of young people have been able to access higher education and acquire higher paying jobs and affordable healthcare (Medi-Cal).


The spirit of #HearToStay is one of power, community, resilience, resistance.

Health4All Kids

Medi-Cal enrollment is year round.

Eligible individuals under 19 can enroll in full-scope Medi-Cal benefits.

Young adults over 19 can apply for full-scope Medi-Cal through DACA.
